# News from Region X



## Washington DOE Hazard Reduction Grants

The Washington State Legislature has provided \$11.25 million to the Department of Ecology to run a competitive flood hazard reduction projects grant program. The funds will be used to provide grants to communities for projects that reduce hazards flooding while providing benefits to salmon recovery efforts, water quality improvements, habitat recovery, open space preservation, farmland preservation and more.

Communities that qualify will submit project applications and must explain how their projects will meet multiple benefit Projects will be scored and ranked and winning applications provided grant funding. There is a 20% match requirement for all grants awarded. DOE is working out the details on the application process, will be posting information on its website in the coming months.

The Legislature also provided more than \$38 million for specific projects that also meet the "multiple benefits" criteria. Most of them are "Coordinated contained in the Investment for Puget Floodplains", an initiative headed up by The Nature Conservancy. Those funds will be combined with those from other funding partners to advance the initial projects around Puget Sound to preserve natural floodplain functions, reduce flood hazards and improve salmon habitat.

## **September is National Preparedness Month!**

The 2013 Toolkit was developed to help, individuals and communities educate and empower themselves to prepare and respond to emergencies. This toolkit also includes templates and drafts of newsletter articles, blogs, posters, and other material that you can use in various outreach efforts.

National Preparedness Month started in 2004 and is managed by FEMA though the *Ready Campaign* in conjunction with the Ad Council. Throughout the year the Ready Campaign aims to educate and empower Americans to prepare for respond all types emergencies, including natural disasters.



## Subsidized Policies Interactive Map

The Biggert-Waters Flood Insurance Reform Act of 2012 (BW12) has resulted in a phasing out of certain subsidies that have been in place for decades. Beginning this year, BW12 will eliminate flood insurance subsidies for frequently flooded properties, severely damaged properties, businesses, second homes and non-primary residences.



In order to help local officials understand how BW12 will impact their communities, FEMA has created an interactive map that shows a county-by-county breakdown of subsidized insurance policy holders (see sample above). The map shows the total number of NFIP policyholders within a state or county with pre-FIRM subsidies removed by Section 100205 of BW12.
