Washington State Enhanced Hazard Mitigation Plan

2018 Update Completed & Adopted; Includes New Format & Risk Index

2018 Washington The State Enhanced Hazard Mitigation Plan (SEHMP) is now adopted. The update is a full rewrite of the 2013 plan and introduces a robust new mitigation strategy format capturing the state's broad commitment to risk reduction from across many agencies. Also new is a risk index that begins to capture more of the picture complex that defines exposure and vulnerability. Over 15 state agencies actively supported the update as members of the Natural Hazards Workgroup, and many more agencies, local jurisdictions, and tribes were engaged throughout the planning process.

The plan profiles hazards, identifies risks and vulnerabilities, and proposes strategies and actions to reduce risks to people and property, the economy, the environment, infrastructure and first responders. It tracks progress in achieving mitigation goals through state and local programs and strategies, and communicates that progress among and elected agency partners leadership.

The goal of this plan update was to broaden the base of state agencies who recognize their role in hazard mitigation. As Washington focuses on more multi-benefit projects, statewide resilience initiatives, and on building coalitions to implement mitigation strategies, having multiple sectors represented at the natural hazards table is more important than ever.

In future years, Washington Emergency Management Division will complete and publish an annual resilience report on the status of mitigation strategies to demonstrate clearly Washington's investments to reduce risks to people and property, the economy, and the environment.

NFIP Releases Nationwide PEIS

FEMA completed a Nationwide Programmatic Environmental Impact Statement (PEIS) evaluating proposed modifications to the National Flood Insurance Program (NFIP) and potential impacts to the natural and human environment associated with the NFIP at a programmatic level. The PEIS includes an evaluation of impacts of alternative proposals to modify the NFIP. On May 25, 2018, FEMA published a Record of Decision documenting the intent to proceed with the preferred alternative to implement modifications NFIP including:

- Phase out pre-FIRM subsidies.
- Implement a monthly installment plan payment option for nonescrowed flood insurance policies.
- Clarify that communities must obtain & maintain documentation of compliance with the appropriate Federal or State laws (including the ESA) as a condition of issuing floodplain development permits.
- Clarify that certain Letters of Map Change are contingent on documentation of compliance with the ESA.

The preferred alternative meets FEMA's purpose and need, causes no adverse environmental impact, and meets FEMA's desired timeframe for action.

Hosted by FEMA Region 10, this course covers the Community Rating System (CRS), a nationwide initiative of the NFIP. It describes activities eligible for credit under the 2017 CRS Coordinator's Manual, how a community applies, and how a community modifies an application to improve its classification.

This course is intended for students who are either a Certified Floodplain Manager, have completed the FEMA E/L273 course, or are a full-time floodplain manager with at least 2 years of experience. The course material will be difficult to follow for participants not well-versed in basic concepts of floodplain management.

Tuition is free for those accepted; there are no travel or salary stipends available for this offering. To apply, please use the following application form: FEMA Form 119-25-1 State Application. and local community attendees must submit the application through their state training officer. Federal and tribal attendees, submit the application (first approved by your supervisor) directly to the course coordinator.

August 2018 marked the 50th anniversary of the National Flood Insurance Act of 1968, creating the National Flood



Insurance Program (NFIP). Since then, the program has aimed to reduce the impact of flooding on private and public structures by providing affordable insurance to property owners, renters and businesses, as well as by encouraging communities to adopt and enforce floodplain management regulations.

Wherever it rains, it can flood. The NFIP protects Americans against the financial losses from floods. For the safety of our communities, together we can ensure that the NFIP is viable for the next 50 years.

Washington Silver Jackets Climate Resilience Project
