### Flood Risk Communication Toolkit & Video Series

In an effort to help residents and other stakeholders become full partners in increasing resilience, FEMA has produced the Flood Risk Communication Toolkit and Video Series for Community Officials. The benefits of the mapping program and its connection to risk reduction are showcased in both publications, utilizing plain language and organized information.

The Toolkit and Video Series were developed to help community officials begin and maintain an open channel for communication. The Toolkit includes templates and guides for communication plan design, effective public meetings, and a social media strategy for addressing flood risk. It is supported by story maps and videos that visually communicate the objectives of updating flood risk data and maps.

These resources provide a clear and consistent experience for users nationwide, with a goal of providing leaders and influencers with the tools to plan for evolving risk, increased financial exposure, and disruptions based on underestimated risk.

### FEMA Releases Tribal Mitigation Planning Handbook

The National Mitigation Planning Program is pleased to announce the arrival of the Tribal Mitigation Planning Handbook. The Tribal Handbook is a companion to the Tribal Mitigation Plan Review Guide, which went effective on December 5, 2018. While the Tribal Guide is the official interpretation of the tribal mitigation planning regulations, the Tribal Handbook provides practical approaches and advice for tribal governments as they develop their hazard mitigation plans.

The Tribal Handbook is organized around the seven recommended steps for developing a Tribal mitigation plan. It begins with an overview of the planning process, then reviews each step of the process in more detail. It provides considerations for how to implement the mitigation plan, advance mitigation activities, and incorporate risk reduction into other tribal plans and programs.

Appendices with resources and worksheets are also included. The Tribal Handbook also uses a fictional tribal government and planning area, the Roaring River Indian Community, to illustrate approaches for developing the plan and the connections between the steps in the process.

### Pre-Disaster Mitigation Grant Program Webinar Series

Mitigation planning is a key process used to break the cycle of disaster damage, reconstruction, and repeated damage. Pre-Disaster Mitigation (PDM) grants are funded annually and are designed to assist States, U.S. Federally-recognized Territories, tribes, and local communities in implementing a sustained natural hazard mitigation program. This program awards planning and project grants and provides opportunities for raising public awareness about reducing future losses before disaster strikes.
