



Technical Assistance Visits to Local Communities

Communities that participate in the NFIP have two primary responsibilities: 1) to ensure that their floodplain regulations meet minimum standards and 2) to development regulate in the floodplain according to those regulations. Sounds simple enough, but we all know that it's more complex than that. To help with the complexity and the challenges, staff from FEMA and States provide technical assistance in various forms to help and make sure communities are managing their floodplains well.

Two of the primary mechanisms that **FEMA** and State floodplain specialists use are Community Assistance Contacts (CACs) and Community Assistance Visits (CAVs). Both are opportunities for FEMA and state staff to walk through your floodplain management program in detail and are akin to indepth technical assistance. Typically, these are done in person if possible,

though a phone or virtual visit will be scheduled if needed, particularly with the COVID-19 limited travel abilities.

During a CAC, you can expect the FEMA or state staff to review your floodplain management regulations to make sure they meet the federal and state minimum standards. They will also ask for a written standard procedure operation for vour floodplain management permitting Other topics processes. might include variances, higher regulatory standards, floodplain mapping, flood insurance, and hazard mitigation projects. The goal is to try to help communities and floodplain managers, who often wear multiple "hats" of duties, find and implement the best process for both the community's NFIP responsibilities and the local need. These visits usually take a couple hours and often have follow-up actions such as updating noncompliant floodplain regulations.

A CAV is more intensive and is essentially an audit of your

floodplain management program, but one where the community has the ability to correct issues with FEMA or state guidance. In addition to a review of the local floodplain management regulations and the topics of a CAC, FEMA or state staff will conduct a field tour of floodplains in the jurisdiction. They will identify a list of development activities for which the community will have to document compliance regulations, with floodplain including all applicable permits. If any violations are discovered, the community will have the opportunity to rectify them and FEMA and state staff will help identify solutions. CAVs typically take the better part of a day, depending on the community, and require extended follow-up.

Both of these tools offer the ability for communities to improve their floodplain management program and get assistance with challenges they may be facing. CACs and CAVs are a big priority for FEMA and offer a way for routine engagement between local governments and federal and state floodplain staff. These also are the best tools to make sure property owners are constructing their buildings to be safer from flood risks.

These visits are not the only way to get assistance with floodplain issues, however. You can contact FEMA and State staff for assistance anytime. And expect to see more
